In collaboration with Newton Senior High School Student Council and the Cardinal Cares Initiative, United Way of Jasper County has established Cardinals United a program offering a varsity letter to students who volunteer 110 or more hours of service in a year.

Students at NHS or WEST Academy earning their UWJC Varsity Letter in Community Service will be recognized during a special awards banquet hosted by United Way. Students also will be recognized on their transcripts and at senior graduation.



Students must meet all of the following requirements to apply:

- Must be in grades 9-12 at WEST Academy- Newton, lowa
- Have a 2.0 GPA or higher
- Complete a minimum of 75 hours*
- * 75 hour benchmark is for 2018-19 school year only. Future years will have a 110 hours minimum
- What to expect after you apply:
- You will be notified upon receipt of your application and acceptance to the program by Oct. 8, 2018
- When applying, please note that certified hours completed beginning Sept. 1, 2018, will retroactively apply to the completion of your 75 hours for a letter.
- You will then be notified of your award status no later than May 6, 2019.

- Complete application by Oct. 1, 2018, and return to Mr. Miller
- Submit all hours for verification on a quarterly basis to Mr. Miller
- Submit final hours for verification by April 15, 2019
- Awards will be given at an event for UWJC Varsity Letter winners
- If you are unable to attend the award ceremony the letters will be available for pick up at the UWJC office after May 20, 2019
- Letters not picked up can be mailed for a \$5 fee.
